Disaster Unemployment Insurance	Reimbursements (via DOL) to state unemployment insurance funds cover those not eligible for regular unemployment insurance. Planning estimate assumes 750,000 temporarily unemployed, at \$241 per week (wtd average of max LA, AL & MS rates).	3,193,320	813,375,000
Damage Inspections	Temporary and contract employees to evaluate individuals' property losses and eligibility for FEMA assistance.	50,360,200	250,000,000
Housing and Unmet Needs Assistance	Provides up to \$26,200 for up to 1.1M households for various disaster-related costs and short-term assistance.	761,250,000	23,212,875,000
Manufactured Housing	Purchase of trailers and other temporary housing. With 200,000 units purchased to date, additional funds support +100,000 units at \$16,000, which counts towards housing assistance limits.	3,306,867,215	1,600,000,000
Counseling and Legal Services	Legal and mental health counseling services for disaster victims.	139,878	250,000,000

Emergency Sheltering Operations; Emergency Assistance to State and Local Governments; and Public Assistance (for infrastructure repair)	During the initial stages of the response, infrastructure costs have focused on assistance for state and local governments emergency response (search and rescue, communications, evacuations, etc.), emergency sheltering operations in the directly affected states plus the 12 sheltering states. Over the next few weeks assistance for repairs and reconstruction of public facilities will increase significantly.	75,000,000	7,650,000,000

<u>Mitigation Total</u>	Grants to affected states to implement measures reducing the consequences of future disasters. Planning assumption reflects 7.5% of public assistance funding.	9,000,000	648,750,000
